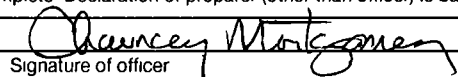

Value of shares in Columbia Large Core Quantitative Fund, Account 0010 1225 6925 3 002, increased throughout 2012, ending at \$6.46 per share. The fund's principle value increased approximately \$5,885 over the course of 2012. The year end value was \$48,860.56.

Value of shares of Delaware County Bank and Trust stock increased to \$4.60 per share. The investment gained about \$31, increasing the total value to \$78.
