Blue Earth Consultants, LLC meets the facts and circumstances test because it maintains a continuous and bona fide program for solicitation of funds from the general public and from governmental units. In 2012 we did a direct mail fundraising campaign to over 600 targeted member of the public. We maintain a website which allows public donors throughout the country to donate. We were successful in obtaining a grant from governmental organization for \$60,000 of which \$10,000 was received in 2012. The balance will be paid in 2013 which will put us above the 33 1/3% public funding requirement for 2013.
