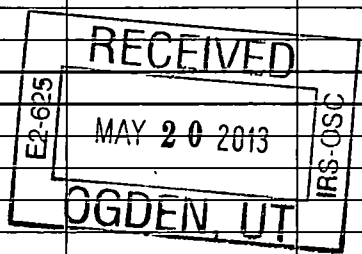

- **Qualifications of those who will be engaged in the project;**
- **Legal and tax status – include a copy of the IRS letter of designation;**
- **Brief description of anticipated achievements or outcomes;**

- **A current list of board members and affiliations;**
- **Population and geographic area served; and,**
- **Period of time for which funds are requested;**

**While there are no deadlines for requests for funds from the Huntington Foundation, Huntington staff will review the initial letter of inquiry within four months of receipt of the request.
