


The only "key employees" are ministers whose remuneration is made in accordance with IRS rules, regulations and other guidance for ministers' compensation. Ministers' remuneration is set by trustees after careful consideration of responsibilities, expectations and comparability data, and contemporaneous substantiation of the deliberation process and decisions is made.

Part VI, Section C, line 19 --- All records of the organization are available for public inspection if the inquiring party has a legitimate interest in supporting the organization's mission or there is otherwise a need to know.

Part V, question 2b --- The organization's "employees" are remunerated as ministers, in accordance with IRS guidelines. As such, they are not subject to withholding for Social Security and Medicare taxes and/or federal and state income tax withholding. Accordingly, quarterly filing of forms 941, etc. is not applicable.
