Some groups pay usage fees (rent if you will) and groups such as the 4-H program, the local high school rodeo club, etc. do not pay usage fees. This usage usually falls into the catagory of recreational horseback riding, horse training exercises (such as preparing for rodeo-type events and barrel racing) and for preparation for horse and other livestock shows.
