Some highlights were environmentalist documentaries 'A River Changes Course' and 'A Fierce Green Fire' from Sundance, 'Elemental' (another environmental film), LGBT activist films 'Valentine Road' and 'United in Anger', and Oscar-nominated feminist documentary 'The Invisible War'.
