In 2012, more than 1,600 citizen stewards and corps crew members performed the hard,
physical labor of annual maintenance and restoration of the PCT. PCTA volunteers
contributed 92,418 service hours in 2012, an in-kind value of \$2 million. These
hours included the completion of 1,172 miles of trail maintenance, 54 miles of trail
reconstruction, 1 trail head kiosk, and 24 volunteer training events.

Through our print and electronic publications and personal outreach, we promote the
PCT, marshal volunteers and keep our members and elected leaders informed of programs
and issues facing the trail. In 2012, promotional activities included: publishing
four issues (38,000 copies) of the Pacific Crest Trail Communicator magazine, and
distributing it to members, partners and elected officials; publishing an annual
calendar; publishing four regular issues of Trail Dirt, the PCTA's electronic
newsletter. The PCTA received 704 calls to the toll-free Trail Information telephone
line; issued 1,497 wilderness permits; and monitored 561,438 website visits and
14,000 Facebook likes.

PCTA advocated for Land and Water Conservation funding which was used by the US Forest Service and the Bureau of Land Management for the following successful acquisitions to benefit the PCT: Northern California - 640-acre section of land on Mount Eddy containing more than a mile of the PCT tread; Oregon - 6,280 acres within the Cascade Siskiyou National Monument containing sections of the PCT (about 1.5 miles); Washington - two tracts of more than 800 acres containing 1.5 miles of the PCT tread.

PCTA also monitored or responded to ongoing threats to the trail including the following: California - Wind Development, Solar Installation, Sunrise Powerlink, California High Speed Train, Bankruptcy/Selling of Warner Springs Ranch, Rim Reforestation, Sugarloaf Fuels Reduction, Bucks Project, Invasive Plant Eradication, Marine Corps Mountain Warfare Base Expansion, State Route 89 Realignment at Burney Falls State Park, and Castle Crags State Park Closure. Oregon - Cascade Crossing power line, Pacific Connector Natural Gas Pipeline, and Palomar Pipeline. Washington - Ski Area Expansion, Suiattle River Road Repairs, and Stehekin Valley Road Relocation. In 2012, PCTA staff conducted a total of 541 meetings with government agency partners. About half of these meetings included discussion of protection activities. Our 2012 protection activities also included an annual trip to Washington, D.C. in February to advocate for federal trail management, operations and land acquisition funding for the PCT. Volunteers - including youth - and PCTA staff members attended this "Hike the Hill" event, visiting with federal agency leaders and Congressional representatives and their staff.
