The Wyland Foundation held numerous educational outreach tours, special events, and classroom presentations Following are 2012 event highlights January 2012 National Geographic Explorer and Wyland embarked on an excursion of the Midway Atoll National Wildlife and Papahānaumokuākea Marine National Monument with the goal to call attention to the cumulative impacts of manne debris, overfishing, non-native species and sea temperature change on fragile coral reefs and endangered species in the Hawaiian Islands February 2012 Dana Wharf Sportfishing and Whale Watching brought "Wyland Dolphin and Whale Adventures Art Lessons in the Wild," a unique program featuring a hands-on lesson from Wyland, to Southern California Families A portion of proceeds from the ticket sales benefitted the Wyland Foundation for manne conservation education and outreach to undeserved communities The program ran through May 2012 and will begin again in January 2013 The Wyland Foundation hosted a special ocean mural painting activity with the help of Guy Snell, local artist in the Florida Keys March 2012 Wyland Foundation Founder and President, Wyland, led an interdisciplinary panel of artists, educators, and government leaders on the singularly important topic "Building a case to save arts in schools", at the National Art Educators Association National Convention in New York, New York April 2012 Thousands of people across the country took part in the National Mayors Challenge for Water Conservation which the Wyland Foundation was involved with Blues Planet Sounds premiered at the 2012 Newport Beach Film Festival May 2012 The Wyland Foundation partnered with the Maddie James Foundation for "May is for Maddie" a monthlong campaign to inspire children in undeserved communities about the conservation of our watersheds and ocean In partnership with the Miami Beach Chamber of Commerce Arts and Culture Council local Florida students worked alongside Wyland to create and paint two murals illustrating our local aquatic habitat and their inhabitants -- coral reefs, mangroves, manatees, dolphins and sea turtles June 2012 The City of Aliso Viejo's Green Initiative program "grew roots" with its first ever summer celebration with nature-focused activities for all ages! The Wyland Foundation took part with it's signature clean water community art mural activity June - August 2012 The Clean Water Mobile Learning Experience traveled to communities across Southern California including festivals, fairs, summer camps, and other community events July 2012 The Wyland Foundation educated sawdust festival-goers about the connection between our waterways and ocean through a collaborative mural painted with children at the festival August 2012 Wyland and the Wyland Foundation helped celebrate the 20th anniversary of the annual Hawaii Conservation Conference and 20 years since the Rio Earth Summit with a community mural painted in collaboration with the children from the islands September 2012 The Wyland Clean Water Mobile Learning Experience was the centerpiece for a 30 day, multi-city tour in partnership with US Forest Service and National Van Lines Focus, traveled to Springfield, Massachusetts where Wyland and the Wyland Foundation collaborated with hundreds of local school children to paint healthy aquatic ecosystems and learn about our natural world Wyland Foundation joined in the festivities at the Doheny Days Music Festival in Dana Point to educate and inspire music lovers about local conservation issues with a family, "Paint-n-Pledge" activity October 2012 Wyland and the Wyland Foundation returned to the Florida Keys to restore the iconic marine life murals he created for local communities over the past two decades December 2012 Four Seasons, in partnership with Wyland and the Wyland FOUndation, hosted a special evening of art and philanthropy at the the inaugural Wyland Giving Tree Project



