In November of 2012, \$200,000 was sent through Head Lama of TNMC to the Bodhi Gaya Monlam Committee for the January 2013 ceremony. Over 7,000 monastics, monks and nuns attended as well as over 10,000 lay people. These funds paid for various offerings: each of the 10 days of the ceremony including: tea offerings morning and afternoon for all the monastic participants, one-way transportation for the monks and nuns, tsog (ceremony food), butter lamps and flowers, and offerings of food to the poor. TNMC distributed books and prayerwheels from resources outside these funds.
