Building a Better Community Initiative - The Building A Better Community Initiative program and team serves the community by providing affordable housing opportunities, job opportunities, and small business opportunities through the purchasing of REO properties via its collaboration with JPMorgan Chase, Wells Fargo Bank, and CITI Bank. The Organization acquired 15 properties for restoration and resale to low-to-moderate income families. The BBCI Seed Project's Financial Wellness program held monthly workshops focused in the areas of household budgeting, financial stewardship, credit as a tool, the FDIC's 'Money Smart' and the Wells Fargo 'Hands On Banking' programs. The "Train-the-trainer" Workshop Series in collaboration with VSF faith and community-based, and stakeholders partners conducted assessments focused on capacity building, governance, community engagement, and economic development. The assessments: (1) What Is The State of the Organization, (2) What Is the State of Congregation and/or Client Served, and (3) What is The State of the Community. The program engaged FBO Pastors and Lay Leaders, and CBO Executive Directors, Board Members, and Key Staff assisting them in identifying the Organizations (1) Strengths, (2) Weaknesses, (3) Opportunities, and (4) Threats ("SWOT Analysis"). During the year, 63% of VSF clients were considered low income (at or below 80 of area median income) and 93% were considered low-to-moderate income (at or below 120% of area median income).

BBCI/Energy Savings Assistance Program - The BBCI/Energy Savings Assistance Program team serves the community through its partnership with Southern California Edison. The program is funded by California utility customers and administered by Southern California Edison under the auspices of the California Public Utilities Commission. There are three stages in the program. VSF is contracted through 2014 as an Outreach and Assessment Stage 1 Agency. Responsibilities under the contract include: Recruiting SCE base customers for the ESA program; educating customers on the benefits, income guidelines/requirements, and screening customers for eligibility. Through the CARE and FERA programs, income eligible SCE customers receive up to 20% off their monthly energy bill. In addition, eligible customers are provided free appliances and installation of energy-efficient refrigerators, air conditioners, CFL bulbs and lamps, as well as home weatherization efficiency solutions. The ESA program fits in line with the BBCI's Seed Project Financial Wellness program. The maximum household income ranges from "up to \$22,340 for a household of 1, up to \$77,780 for a household of 8." The VSF team conducted 322 ESA program assessments with 98% Low-To-Moderate Income Qualified; 96% completed ESA Education; and 52% receiving ESA efficiency solutions (And/Or refrigerators, CFL bulbs, lamps, weatherization).

Pathway to The Future & College Bound Program - The program identified participants in the beginning of their middle school years and supports them through their high school and college career of personal growth and exploration. The program engages the parents, public educators, CBO and FBO as community and stakeholder partners. The objective, (1) to guide each participant in establishing a clear and realistic understanding of family values, spiritual enrichment, personal health, community responsibility, social, and leadership development, (2) coach, mentor, and direct participants along paths of self-exploration, improvement, and development resulting in discoveries of latent creativity and a desire to excel beyond their community silos where, for most of the participants, the vision of opportunity is gang membership, drugs, teenage motherhood and fatherhood, joblessness, hopelessness, and entrapment by low self-expectations, and (3) increase participant's expectations, academic skills, and confidence in self, family, community, and education system. Participants matriculate through a four phase curriculum, Phase I - Personal and Social Development, Phase II - Leadership, Mentoring and Team Building, Phase III - Economic Development and Community Development, Phase IV - Development Of Career Choices.

Central to the VSF CDC's BBCI mission is the fundamental commitment to give the communities it serves the best opportunities to progress through-and-into their faith inspired vision. We believe these opportunities are best provided in communities with a diverse mix of affordable and marketable housing options for people of all cultures, races, creeds, and incomes. We're working to help provide for more livable, and sustainable life options to families, thereby increasing the quality of life, work, and worship.

By reducing the number of vacant housing, this also reduces the the opportunities for gang takeover, and other related activities which reduces the values of the surrounding properties, which creates a negative affect-effect on the mental, physical, and social health of the community, (3) by creating a network of information, tools, and training opportunities to the FBO and CBO community the Initiative is able to provide and instill sound governance policies, community development, strategic planning, public policy guidance, and assistance to its FBO and CBO cohort, (4) to fully engage its paradigm model embracing the opportunity (as opposed to the perceived challenges) of neighborhood revitalization and stabilization, while giving homeownership opportunities, and sound financial stewardship tools and principles to families deserving of their American dream, (5) During the 2012 fiscal period estimated 200+ families, and 52 FBO and CBO organizations matriculated through the BBCI's financial wellness modules via training workshops, technical assistance to non profits, small business, and one-on-one mentoring, (6) six capacity building grants were issued to selected faith and community-based organizations.

In 2012 15 properties were acquired, adding to the 56 acquired in 2011 for a total of 71 creating an estimated 400+ jobs, at an average of 7 supervisory, general laborers, and skilled trades opportunities per property. The Goal, commencing at the point of engagement with the Initiative, is to stimulate homeownership and and economic development in those neighborhoods hardest hit. The Initiative's long term Goals are to continue to engage its paradigm via a focused, community effort to pioneer new initiatives, and collaborative vehicles that will help expand opportunities to those deserving and committed families willing to engage in the process required for homeownership, stainability, effective/affective community revitalization, stabilization, pride of ownership, and the opportunity to be a stakeholder in the building of a stable community.

Sessions are held once a month (1.5-2.0 Hrs) with average attendance of 10 per session. Session are divided into 3 class groups. Depending on the subject or topic the class has the option to divide unto male-female, preteen-teenage, or preteen/teenage-young adult. To date, the program has matriculated an estimated 400+ participants through all four phases. The program's support system is 100% volunteer consisting of parents, graduating alums, community and faith-based leaders, and corporate professionals.

The deliberations are held in closed sessions and the results are conveyed in writing. The Secretary of the Board of Directors maintains notes of the discussions of the Executive Sessions. The President and CEO determines the Salary for the key employees within the constraints of the approved budget and based upon the annual performance evaluation

Form 990, Part VIII, Line 10b: For 2012 the Organization purchased \$2,778,043 of properties through the JP Morgan Chase Bank's and Wells Fargo Bank's Neighborhood Stabilization and Revitalization REO Programs. Coupling the \$13,478,478 purchase in 2011, this brings the total number of properties purchased through the VSF-BBCI program to for the periods 2011 and 2012 to \$16,256,521.

The Organization was approved for the programs in August of 2010 to acquire properties through each of the respective Bank's REO Gifting and Discount Sales Strategy programs. As an approved entity the Organization was mandated to (i) restore purchased properties as part of its Revitalization initiative, and (ii) provide Financial Wellness programs to faith-based and community based organizations, their membership and participants in their efforts of becoming first-time, and re-entry homeowners' as part of its Stabilization initiative.

With the Banks' approval, the Organization engaged a cohort of Capital Partners and entered into Capital Partners Agreements. The agreements provided the Organization the funds to purchase the properties at a discount with a margin spread to be used to (i) restore the properties, carrying cost, taxes, insurance, and security (w/applicable) an average of 15%, (iii) returned to the capital partners an average of 11%, (iv) passed on to the first-time or re-entry homebuyer an average of 5% equity at close of escrow, and (v) returned to the Organization 2% percent (\$45,560) in Program Service Revenue in 2012. Items (iii), (iv), and (v) are per transaction.

In 2012 the Organization purchased 15 properties at an average of \$151,869 per property.

Form 990, Part VIII, Line 10a: For 2012 the Organization sold 38 properties. The gross sale of inventory was \$10,926,000 at an average of \$280,153 per property. The 15 properties purchased, and 38 properties sold generated a net income of 3,257,224 for 2012. Note: Of the inventory sold in 2012, 22 were carried forward from 2011.
