Build a Miracle is a hands-on organization that operates in the community and has first-hand knowledge of the families served. Land deeds or purchase contracts are reviewed to ensure homes are only built on land legally occupied by the families selected to receive the homes. A record is kept on each family, including a photographic history of the construction and the shacks they lived in before receiving one of Build a Miracle's homes. Each expenditure is supported by appropriate receipts, invoices or similar documentation. Families desiring a home provide a letter of qualification to a committee of volunteers, including many who have received Build a Miracle homes in the past. The committee conducts a preliminary visit and collects additional information about the number of family members, ages, financial resources, special needs and similar relevant information. Also, other charitable organizations in the areas we serve often refer impoverished families to Build a Miracle.
