between 10-30 individuals handed out hundreds of tracks with the life giving message of Christ. Additionally a coffee house ministry was begun with up to 20 individuals being ministered to each week. Twice weekly bible studies continued with average attendance of approx. 30 individuals. A Hebrew bible study was begun with approximately 10 individuals attending week. Every other week a time of food and fellowship occurs with approximately 50 people attending and bonding in their relationship with Christ and each other. Once a week there is a prayer meeting with 30 people involved. Evangelism is being done daily through the connection with Trumpet of Salvation which hands out hundreds of tracks daily. Once a week there is a bible study to encourage women in which 7-8 women attend. There is a men's bible study once a week as well. In the beginning of 2012, there was a prayer walk done to pray for the city and had around 5 people involved. This year one wedding ceremony was held.
