 The International Institute of Akron (IIA) is a non-profit agency that provides services to the foreign-born in Akron and the Summit County, Ohio Community. IIA's mission is to contribute to the well-being of our community by creating and implementing programs and services to assist the foreign-born to integrate into our society, promoting public awareness of the value of ethnic diversity and encouraging international communication

 Refugee Resettlement and Assistance Programs. As an affiliate of the U.S. Committee for Refugees & Immigrants (USCRI), this program provides comprehensive services for refugees, asylees, victims of trafficking and secondary refugees who relocate from other U.S. States. Services include case management, financial assistance, English for Speakers of Other Languages (ESOL) classes, employment counselors, appropriate housing arrangements, medical assistance and screenings, assistance with utilities, home visits and referrals for children. The primary goal is to help individuals acquire a working knowledge of the English language, gain employment and achieve self-sufficiency as they adjust to their new life in Akron, Ohio. In 2012, 445 primary refugees and 443 secondary refugees were resettled in Akron, and over 325 refugees attended classes at IIA. These services are funded through County, State and Federal contracts

 Communication Services. Interpreting, Translation and Cultural Competency Services are offered to assist immigrants, refugees and service providers of the Greater Akron area to overcome language and cultural barriers in communication. IIA provides trained interpreters, proficient in over 50 languages, to government offices, courts, law enforcement, health care providers and businesses. Emergency interpreting is available 24 hours per day. IIA sponsors an interpreter training program for legal and medical terminology, skill-building and professional ethics in this field. IIA also provides custom cultural competency programs to businesses and the community for better understanding of our diverse community. In 2012, IIA provided 18,413 non-refugee interpreting hours in response to the need in Akron. A total of 500 documents were translated. These programs are funded through fees for service and county contracts

 Immigration Counseling Services. The Immigration Counseling department helps its clients to adjust to life in the United States and to become self-reliant as soon as possible. IIA's Immigration Counselors provide support and assistance to individuals and families facing adjustment challenges. Knowledgeable counselors assist clients and the community by answering questions and resolving problems related to immigration and citizenship issues. Additionally, these counselors are accredited by the U.S. Department of Justice to represent individuals in Immigration Court. In 2012, the Immigration Counseling Department assisted 3,092 clients. Many of these were families trying to get reunited with loved ones or individuals seeking U.S. citizenship
