AMENDED ARTICLES OF INCORPORATION
OF
TRUMBULL MEMORIAL HOSPITAL FOUNDATION

THIRD: The Corporation is organized and shall be operated exclusively for charitable purposes by conducting or supporting activities exclusively for the benefit of, to perform the functions of, or to carry out the charitable, scientific or educational purposes of The Community Foundation of Mahoning Valley, an Ohio nonprofit corporation (the "Community Foundation"), or its successor related to or in promotion of health care services or health care education in Warren, Ohio or Trumbull County. In the event the Community Foundation ceases to be a "qualified organization," as herein defined, the Corporation shall be operated exclusively for the benefit of, to perform the functions of, or to carry out the purposes of one or more qualified organizations as shall be selected by the Board of Trustees of the Corporation. An organization is a "qualified organization" for purposes of this Article only if it is described in Section 501(c)(3) and Section 509(a)(1) or (2) of the Internal Revenue Code of 1986, as amended (hereinafter, the "Code").

Solely for the above purposes, the Corporation is empowered to exercise all rights and powers conferred by the laws of the State of Ohio upon nonprofit corporations, including, but without limitation thereon, the right and power to receive gifts, devises, bequests and contributions outright, in trust or in any other form, and to use, apply, invest and reinvest the principal and/or income therefrom or to distribute the same for the above purposes.

ADDITIONAL PROVISIONS
AMENDED ARTICLES OF INCORPORATION

TRUMBULL MEMORIAL HOSPITAL FOUNDATION

FIFTH: The sole Member of the Corporation shall be the Community Foundation.

SIXTH: No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to the Corporation's Members, Trustees, officers or private individuals, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article THIRD hereof.

SEVENTH: It is intended that this Corporation shall have the status of a corporation which is exempt from federal income taxation under Section 501(a) of the Code as an organization described in Section 501(c)(3) of the Code and which is other than a private foundation by reason of being described in Section 509(a)(3) of the Code. These Articles shall be construed accordingly, and all powers and activities of the Corporation shall be limited accordingly. The Corporation shall not carry on propaganda or otherwise attempt to influence legislation to such extent as would result in the loss of its exemption from federal income tax under Section 501(c)(3) of the Code. No activity of the Corporation shall consist of participating in or intervening in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office.

EIGHTH: Upon the dissolution of the Corporation, the Board of Trustees shall, after paying or making provisions for the payment of all of the known liabilities of the Corporation, distribute all of the assets of the Corporation exclusively for charitable purposes in

such manner and to such one or more "qualified organizations" as the Board shall determine. An organization is a "qualified" organization for purposes of this Article only if at the time of the distribution of such assets it is organized and operated exclusively for purposes described in Section 170(c)(2)(B) of the Code and is an organization described in Section 501(c)(3) thereof. Any of such assets not so distributed shall be distributed by the court of common pleas of the county in which the principal office of the Corporation is then located, exclusively for the aforesaid purposes of the Corporation, or to such qualified organization or organizations as said court shall determine.
