SAMARITAN FOUNDATION GRANT-MAKING PROCEDURES

Samaritan Foundation (the Foundation) is located in Paulding County, Ohio. Paulding County is primarily a rural farm community. Much of the national economic expansion between 1980 and 2000 has by-passed this agrarian community. A significant segment of the County's population is economically disadvantaged.

The Foundation's purpose is to:

1. Make grants to individuals and groups to promote the betterment of the general public;
2. Make loans to economically disadvantaged individuals or groups where conventional sources of funds are unwilling or unable to provide such funds;
3. Grant scholarships to individuals on the basis of academic qualifications and financial need of the grantees;
4. Make contributions to any organization exempt from tax under section 501(c)(3) of the Internal Revenue Code.

Grants, loans, and scholarships will be awarded on an objective and nondiscriminatory basis, in accordance with this document. Such awards are provided with the understanding the recipient will use the funds in accordance with the guidelines set forth in IRC §4945(g)(1) and Reg. §53.4945-4(a) for educational or specific skill improvement purposes.

Grants to indigent individuals based on financial need will be used for such necessary items as food, clothing furniture and other items of basic sustenance. The grant program will increase the economic opportunities of those who are economically disadvantaged and alleviate the distress caused by their situations.

Loans will also be made to indigent individuals in economic distress. The purpose of such loans is to encourage the economic development of such disadvantaged groups. Loans will be based on financial need of the individuals and the inability to obtain conventional financing. Loans based on financial need would be made at below market rates of interest.

Scholarships will be granted on the basis of academic qualifications and financial need of the grantees. The Foundation may grant scholarships each year to graduates of local high schools to permit the recipients to attend college, technical school, trade school or other accredited institutions. The availability of scholarships will be made known by written communication each year to high school principals. The Foundation will obtain information from each high school on the academic qualifications, background and financial need of applicants. The Foundation will require each applicant be recommended by two teachers or by the principal of his or her high school. The Foundation officer responsible for making awards will review all application forms. The Foundation will obtain annual reports on academic performance of the scholarship recipient from the college that he or she attends.

All grants and loans will be awarded on an objective and nondiscriminatory basis and pursuant to the Foundation's tax-exempt purpose. Adequate records will be maintained to show:

1. the name of the individual;
2. the individual's address;
3. the amount distributed;
4. the purpose for which the aid was given; and
5. the manner in which the recipient was selected.

Individuals selected will be chosen on the basis of criteria reasonably related to the purpose of the grant. The grants will be awarded on an objective and nondiscriminatory basis to disadvantaged groups, defined in a sufficiently large as to constitute a charitable class. Each case involving financial need will be reviewed thoroughly and, where possible, involve a church or other social welfare organization.

The person or group of persons who select recipients of grants will not derive a private benefit, directly or indirectly, in the selection of individual recipients.
