EMPHASIS IS PLACED ON SUPPORTING BIRTH PARENTS IN THE DECISION TO PLACE THEIR CHILD FOR ADOPTION, BOTH BEFORE AND AFTER THE PLACEMENT TAKES PLACE. CARE IS ALSO TAKEN TO PROVIDE ADOPTIVE PARENTS WITH THE RESOURCES THAT THEY NEED DURING THE ADOPTION PROCESS AND THEN ONCE THEY HAVE WELCOMED THE NEW CHILD INTO THEIR FAMILY. ADOPTION SERVICES INCLUDE FACILITATING INFANT ADOPTIONS, CONDUCTING HOME STUDIES AND POST-PLACEMENT VISITS, STEP-PARENT ADOPTION HOME STUDIES, AND CONSULTATION AND TRAINING. THIS PROGRAM SERVED 353 INDIVIDUALS IN 2012.

THE ORGANIZATION'S TEEN PARENTING SERVICES (KNOWN AS EDUCATION CREATES HOPE AND OPPORTUNITY, OR ECHO) USE A CASE MANAGEMENT MODEL TO ASSIST TEEN PARENTS TO COMPLETE HIGH SCHOOL AND TO DEVELOP POST-HIGH SCHOOL GOALS. ADDITIONALLY, ECHO HELPS PREPARE STUDENTS FOR ENTRANCE INTO A POST-SECONDARY EDUCATION PROGRAM SO THEY CAN WORK TOWARD A LIVABLE WAGE WITH A CERTIFICATE OR AN ASSOCIATES OR BACHELORS DEGREE. FOR THE 2011-2012 SCHOOL YEAR, THIS PROGRAM ACHIEVED A 96% GRADUATION RATE FOR PARTICIPANTS WHILE NATIONALLY ONLY 40% OF TEEN PARENTS GRADUATED. THIS PROGRAM SERVED 237 CLIENTS IN 2012.

THE ORGANIZATION'S COUNSELING PROGRAM WAS DISCONTINUED IN EARLY 2012. PRIOR TO ITS CLOSURE, THE PROGRAM OFFERED COUNSELING SERVICES TO LOW INCOME FAMILIES AND INDIVIDUALS. DURING 2012, 66 CLIENTS RECEIVED COUNSELING SERVICES.

NEARLY 1,200 CLIENTS RECEIVED FINANCIAL LITERACY LESSONS IN 2012.

THE ACCESS TO RECOVERY PROGRAM, ESTABLISHED IN 2012, ASSISTS CLIENTS WHO SHOW THE DESIRE TO RECOVER FROM SUBSTANCE ABUSE AND ADDICTION AND WHO NEED ASSISTANCE MAINTAINING THEIR RECOVERY. SERVICES INCLUDE CREATING A PERSONAL RECOVERY PLAN WITH THE CLIENT AND THEN CONNECTING THEM WITH RESOURCES WITHIN THE COMMUNITY TO HELP THEM SUSTAIN SOBRIETY. THIS PROGRAM SERVED 184 CLIENTS IN 2012.

THE FAMILY AND CHILD SERVICES PROGRAM IS THE RESULT OF A CONTRACT WITH THE DEPARTMENT OF CHILD SERVICES TO PROVIDE FAMILY PRESERVATION SERVICES IN ALLEN AND SURROUNDING COUNTIES. THE ORGANIZATION WORKS IN CONJUNCTION WITH OTHER LOCAL SERVICE PROVIDERS TO OFFER HOME-BASED, FAMILY-CENTERED SERVICES. THE GOAL IS TO HELP FAMILIES MEET NECESSARY GOALS THROUGH A STRENGTH-FOCUSED MODEL AND ACHIEVE FAMILY REUNIFICATION. ADDITIONAL SERVICES ARE PROVIDED TO ASSIST AND SUPPORT PARENTS BY TEACHING AND DEMONSTRATING PROPER PARENTING AND HOMEMAKING FUNCTIONS. THIS PROGRAM SERVED 34 CLIENTS IN 2012.
