Line 2, Column (c) is shown on this return as \$0. This amount reflects what should have been the correct number on Line 6f, Column (d) on the 2011 Form 990-PF. On the 2011 Form 990-PF, \$598,158 of the excess distribution was applied to 2011 on Line 5, Column (a), reducing the excess distribution carryover at the beginning of the year of \$1,680,587 to \$1,082,429 at the end of the year to carryover to 2012. However, this amount was inadvertently not reflected in Column (d) as well.
