The Community & Supportive Services Program (formerly the Crisis Center) provides free, accessible, bilingual and culturally appropriate case management and housing advocacy services to families, unaccompanied youth and single individuals who are homeless or at risk of becoming homeless The Community & Supportive Services Program staff work in partnership with clients to obtain and maintain housing stability Its primary subprograms included La Casa Norte’s homeless prevention and rapid re-housing program, its IL-DCFS client housing stabilization program, La Casa Norte’s Community Based Case Management Program and La Casa Norte’s Scattered Site Housing Program The program also houses La Casa Norte’s Digital Divide program, its Food Security Organizing project, and work readiness program for internal clients In 2012, 1,035 households and individuals received assistance through this program

The Solid Ground Supportive Housing Program provides safe, stable housing for homeless male youths, age 16 to 21 These young men can stay at Solid Ground up to two years, during which time they benefit from comprehensive case management services focusing on a holistic, strength-based approach provided within a trauma informed care and transformative justice model In 2012 Solid Ground provided assistance to 38 youth Solid Ground is Chicago’s only bi-lingual (Spanish/English), culturally appropriate Latino youth shelter in the city of Chicago

La Casa Norte’s Scattered Site Supportive Housing Program is a Permanent Housing program which provides hard to house homeless families and chronically homeless youth with long term stable housing Clients housed in the program are provided with both housing subsidies and supportive services, which are all required to successfully house these households Support services provided include case management, therapy, nutrition education and referrals to a range of additional services such as health care, substance abuse treatment, mental health, child care, legal assistance, work force development services and educational programming The program in 2012 provided housing and services to 24 families and 10 chronically homeless youth households
