In-Prison Ministries: In 2012, KHNM conducted 14 Freedom God's Way events in 10 Illinois correction centers (8 males facilities and 2 female facilities). These weekends focus on presenting the Gospel of Jesus Christ and preparing inmates for their return to society. In December, a team conducted a Christmas service and a special cell-to-cell visitation for the women in segregation at Dwight Correctional Center in IL. The KHNM team also conducted prison ministries in four other states (LA, MN, IN, and VA) and one foreign country (Uganda). At the request of the IL Department of Corrections, KHNM team members participated in Re-entry Summits at Sheridan and Lawrence Correctional Centers in 2012.

Koinonia House of DuPage County, Inc., d/b/a Koinonia House of Wheaton (KHWL). Although the residential portion of this ministry was suspended in 2012, KHNM continued to mentor and disciple former inmates, helping with biblical discipleship and securing housing and employment on a case-by-case basis. Significant time was devoted to mentoring three individuals in 2012.

Meet Me at the Gate (MMATG).

Train and equip the Church to minister to Christians coming out of prison; identify and train individuals interested in establishing post-prison ministries; work with local, state, and federal officials to facilitate prison reform; educate the general public concerning the need for post-prison ministry; mentor and encourage those recently released from prison. FY2012 highlights include the weekly dinner and Bible study for those transitioning back to society.
