The Organization provides transitional living and affordable housing
to US veterans at its two facilities in Wheaton, Illinois. From its
inception 64 homeless veterans have utilized the transitional shelter
services. The affordable housing units became available in 2012
and housed 6 veterans during its first year of operations.
The Organization also provides the residents with counseling services
for mental health and substance abuse and assists them with procuring
employment and permanent housing. 100% of the residents served decreased their
substance use and worked on recovery. 80% of the residents discharged
from the transitional housing program were successfully migrated to permanent housing.
