28 Dominican Republic MissionsThe idea for Project 52 was born on a mission trip in Honduras in 2006. Project 52 has partnered with Lighthouse Projects DR in Los Alcarrizos, Dominican Republic. In 2012, we hosted our first mission team to spend 9 days dedicating the Treya Blythe Gym at the Lighthouse School and building a home for a single father in the community. The Treya Blythe Gym is a beacon to the community and is used as an outreach to the youth as an alternative to the vices of the streets in the community. Over 1000 kids and young adults use the gym every month. Project 52 raised all the funds for the gym. We also raised the funds to complete a home for a single father in the community. Our team of 24 helped complete the construction on the home and dedicated and presented it to the family at the end of our trip. We took on a special project of raising the funds for kitchen equipment that was purchased and shipped from Iowa to the DR. The school opened a kitchen to feed the kids breakfast at the school that we go without food on a daily basis. Now over 100 kids enjoy a free breakfast every day. Last, we have a sponsorship program that local people can sponsor a child at the Lighthouse school for \$35 per month. The Lighthouse school is rated as one of the top 10 schools in all of the Dominican Republic.

29 Adopt A FamilyWe adopt 3-5 families each year. We adopt them not just for the holidays but for 52 weeks (an entire year). Most of our families are single-parent families or families with a major medical condition that requires additional resources. Assisted 5 (19 individuals) families in 2012. We provided Christmas gifts for all 5 families in 2012 based on a wish list the family provided. We also assisted a family with an 18-year-old son who was paralyzed from the neck down with help with medical bills and also installing an elevator in their home for his wheelchair. We provided a single-parent family with rent assistance and furniture to help them establish a residence and get back on their feet. We provided another single-parent family with legal help for a pending divorce stemming from domestic violence. Since the programs began in 2009, we have raised over \$75,000 and provided help to 17 families (66 individuals). We hold a fundraiser each November for the Adopt A Family Program.

30 Trees to RememberLosing a child is the worst experience a parent can face. As a living memorial to a dear family member lost, we donate and plant trees to the families who have lost a loved one. While our focus is on families who have lost children, we also donate and plant trees for children who have lost parents. While we understand that a tree won't fill the void of your loss, we do hope as you watch it grow and change with the seasons, that it brings peaceful thoughts of your loved one. Each family receives a 10-14 foot maple tree (unless request something else) and an engraved marker for the tree and a certificate for their home. In 2012, we planted 36 trees in 4 states. Since the program started, we have planted 110 trees in 8 states and have had over 3500 people attend the tree plantings.
