MICHIGAN SCHOOLS AND GOVERNMENT CREDIT UNION IS A FULL SERVICE FINANCIAL INSTITUTION SERVING APPROXIMATELY 69,959 MEMBERS WITHIN SOUTHEASTERN MICHIGAN. THE CREDIT UNION FOCUSES ON MEETING THE NEEDS OF SCHOOL EMPLOYEES, STUDENTS AND ALUMNI AND GOVERNMENT WORKERS WITHIN AN EIGHT COUNTY AREA. MAJOR PRODUCTS AND SERVICES INCLUDE CONSUMER LENDING, A VARIETY OF SAVINGS AND INVESTMENT PRODUCTS, MORTGAGE LENDING, AND ANCILLARY SERVICES SUCH AS FINANCIAL EDUCATION AND SCHOLARSHIP PROGRAMS. AT THE END OF 2012 OUR LENDING PORTFOLIO TOTALLED JUST OVER \$667 MILLION. THE CONSUMER LENDING PORTION OF THE PORTFOLIO WAS NEARLY \$222 MILLION. THE MORTGAGE PORTFOLIO WAS JUST OVER \$407 MILLION AND THE BUSINESS LOAN PORTFOLIO WAS JUST OVER \$38 MILLION. THE SAVINGS PORTFOLIO WAS NEARLY \$1.089 BILLION.

DURING 2012 THE CREDIT UNION SERVED HUNDREDS OF MEMBERS WITH OUR FINANCIAL EDUCATION SEMINARS WITH TOPICS INCLUDING INVESTING, FINANCIAL AID FOR COLLEGE, WILLS & TRUSTS, SOCIAL SECURITY, IDENTITY THEFT, INSURANCE PLANNING, AND HOME BUYING. THE CREDIT UNION ALSO PROVIDED THREE YOUTH SEMINARS REGARDING CHECKING AND CREDIT TARGETED AT STUDENTS AGE 16 AND 17. ALSO IN 2012, THE CREDIT UNION CONTINUED ITS SCHOLARSHIP PROGRAM PROVIDING \$12,000 TO HIGH SCHOOL MEMBERS ENTERING COLLEGE. IN 2012, THE CREDIT UNION ALSO DEDICATED AN ADDITIONAL \$30,000 IN SCHOLARSHIPS ISSUED TO SCHOOL DISTRICTS FOR A TOTAL OF \$42,000 THAT IS EARMARKED TO HELP HIGH SCHOOL SENIORS ENTERING COLLEGE. IN ADDITION TO THESE SCHOLARSHIPS, MICHIGAN SCHOOLS AND GOVERNMENT CREDIT UNION ISSUED \$6,000 IN SCHOLARSHIPS WITH OUR ADULTS MOVING FORWARD SCHOLARSHIP PROGRAM WHICH HELPS ADULTS OBTAIN RETRAINING THAT MAY BE NECESSARY DUE TO DISPLACEMENT, RETRAINING, OR OTHER ECONOMIC CHALLENGES.

THERE WERE 52 MINI-GRANTS ISSUED TOTALING OVER \$36,000 THAT WERE AWARDED TO EDUCATORS DURING THE 2012/2013 SCHOOL YEAR AND THE PROGRAM WILL LIKELY CONTINUE IN 2013 AND BEYOND.
