JET - Jobs Education Training Program Women's Resource Center has served as a workforce development provider for this government contract with ASCET/Michigan Works since 2006. The program intends to annually serve 150 referred women that are receiving cash assistance/welfare from Kent County. Enrolled clients are expected to complete a one week employability and life skill development class called "Skills for Success" and actively job search under the guidance and supervision of the Employment case manager. Services include individual employment coaching, case-management, career development and basic academic skills through self-paced, computer-based programming available in the WRC Client Business Center/Learning Lab, peer support groups, employment try-out and community service experiences, and job placement and retention services. Two Employment Case Managers each manage a caseload of approximately 75 clients per year.

Pathways to Prosperity Program Pathways to Prosperity, a multi-agency collaborative program including Women's Resource Center (WRC) was implemented in the spring of 2010 with funding from the US Department of Labor - Stimulus/Recovery Act funds. Grand Rapids Community College (GRCC) provides fiduciary oversight and overall coordination of the program. Besides WRC and GRCC, the other program partners are Goodwill Industries, Literacy Center of West Michigan, and Michigan Works - Kent/Allegan. WRC's program focus is to provide outreach to and recruitment of unemployed and disadvantaged women living in the target area as well as providing gender-specific career coaching to enrolled female participants, mentoring support, and employment placement assistance. WRC has a goal to serve 200 women over a 2 year period in the Pathways program. WRC employs a full time Employment & Training Coach, a full time Business Development/Job Placement Specialist, and a part time Mentor Coordinator to manage this caseload.

4c (Code:) (Expenses \$ 22,723 including grants of \$) (Revenue \$ 18,806)

Second Chance ACT Adult Mentoring: Women's Resource Center implemented the New Beginnings program in October 2012. The program is offered to women who are inmates at the Kent County Jail. WRC's mentoring services will be offered pre-release and up to 18 months post release. Our services include one-on-one and/or group mentoring to provide pro-social support by a caring female adult, employability assessments coupled with individualized employment development plans, employability and life skills workshops, job placement and retention assistance, and strength-based case management services to connect returning women with collaborative community partners that provide substance abuse and mental health treatment, education/training, housing and basic needs, and other services critical to their successful community reentry. This program is funded by a two-year Federal grant from the Dept. of Justice. One Employment Case Manager will manage a caseload of 65 participants and one Mentor Coordinator will recruit, train, and manage 75 volunteers over the length of the program.
