The Association follows the provisions of FASB Accounting Standards Codification Topic ASC 740-10. As of December 31, 2012 and 2011, the unrecognized tax benefit accrual was zero. The Association will recognize future accrued interest and penalties related to unrecognized tax benefits in income tax expense if incurred.
