Parish Support - funds provided to St. Francis de Sales Parish and Our Lady of the Lake Parish to help support Catholic ministries and programs directed by the parishes.

Specific program support requests - funds can be requested to help support a specific program. The maximum amount per request is \$1,500. 13 requests were distributed for Corpus Christi school programs. They included foreign language learning tools and religious education videos. 1 request was distributed to Our Lady of the Lake for sports equipment.
