The Michigan Youth Livestock Scholarship Fund (Organization) is organized for charitable, educational and scientific purposes, including the distribution of scholarships and educational awards to youth who exhibit livestock or farm products at the Michigan State Fair the Michigan Livestock Expo or other state and county fairs in Michigan. The funds of the Michigan Youth Livestock Scholarship fund are used exclusively in furtherance of the exempt purpose to the organization and to meet necessary expenses for its upkeep and operations.

The "Sale-Abration", conducted on the Tuesday after the Michigan Livestock Expo is the pinnacle livestock events for youth in Michigan. The last year of the Michigan State Fair including the Michigan state Fair Youth Livestock Auction was in 2009. The "Sale-Abration" auction promotes and develop involvement of youth in livestock exhibitions, and assists in the development of the educational scholarships and awards. The Champion and Spotlight livestock sold in the "Sale-Abration" have been rated superior to the other animals at the event. Each Champion and Spotlight animal (twenty eight lots sold at the 2012 Sale-Abration) sells for a premium which is usually higher than the commercial value of the animal, most likely the highest amount for any animal in its class anywhere in the state of Michigan. For example, the Grand Champion Market Steer with a conventional market value of around \$1,200, was sold to the highest bidder for \$20,000 in 2012, 2011 and 2010, and \$10,000 in 2009. It is this premium price, of course, that provides the ultimate incentive for Michigan youth to participate in the ninety county, regional and state wide exhibitions held in Michigan each year.

These lofty bids do not simply happen. They result only from the enthusiastic advance promotion of the Auction by the dedicated volunteers of the Sale-Abration Auction Committee (Committees). These volunteers contact and visit individuals and corporations in Michigan that believe strongly in the advancement of youth and agriculture, encouraging

them to purchase the goodwill and publicity that comes from being a successful bidder at the Sale-Abration.”

The Organization in concert with the Committee conducts the “Sale-Abration” at the request of the Michigan Livestock Expo Board, respectively. The Committees solicits potential buyers, provides publicity, selects the auctioneer and conducts the sale. The Michigan Youth Livestock Expo provides the facilities.

In return for its activities, the Committee receives a commission from the proceeds for each lot sold. Also, revenue in excess of the sales cap for livestock plus all proceeds from non-livestock lots (cheese, butter and wine) goes directly to the Organization in the name of the Committee. The sales cap for the Grand Champion steer is \$20,000 while the Grand Champion Lamb and Hog is \$10,000 and the goat is \$3,000. There is also a scaled sales cap for the other livestock lots. Thus, the 2012 Grand Champion Hog raised \$5,000 for the organization when it sold for \$15,000. Between revenue in excess of the sales cap for livestock plus all proceeds from non-livestock lots, the 2011 Sale-Abration raised \$50,580 for the organization.

With its proceeds from the Sale-Abration, plus outside donations the Organization provides scholarships and educational awards to eligible youth livestock exhibitors. At the 2012 Sale-Abration, seven \$1,500 and four \$1,000 state-wide scholarships were awarded from income earned on the trust fund, plus \$1,000 to the dairy showman, the cow showman and the heifer showman. Since 2000, MYLSF has impacted nearly 1,000 youth exhibitors by granting over \$335,300 in scholarships and educational awards. In 2012 \$16,425 in Michigan Education Saving Awards were awarded to over 100 youth in livestock and \$9,821 in education awards were given to over 150 youth in Dairy. The Committee is committed to increasing its fundraising activity in the future, which will hopefully permit the awarding of larger and numerous scholarships.

Due to fiscal restraints, the State of Michigan has decided to not appropriate funds for the running of the 2010 Michigan State Fair. As of May 13, 2013 Michigan State Fair, a Private Entity, has taken over the name of the Michigan State Fair but has no connection to the Livestock Expo or the Michigan Youth Livestock Scholarship Fund. Thus, the Committee and the Organization’s primary activities are to: 1) conduct the “Sale-Abration” at

the Michigan Livestock Expo and 2) award the scholarship and educational awards. Both activities are educational and charitable in nature.

Conducting the "Sale-Abration". The conduct of the youth livestock auction every year advances the education of all young exhibitors participating in livestock competitions throughout the state. The "Sale-Abration" provides the ultimate incentive for participation in these livestock competitions. By participating in these livestock contests, young people learn first hand: a) About the carcass traits desirable in today's commercial market, b) About the economics of livestock production, c) About animal husbandry practices, including nutrition, housing, waste management, and disease prevention and control.

The youth also learn about these facets of livestock production from visiting with and associating with their competitors. They receive direct instruction in animal husbandry not only from their project leaders and families, but from the livestock judges who adjudicate the preliminary contests to determine qualification for the Sale-Abration. These livestock judges critique the genetics and carcass traits of the livestock.

In addition, the organization encourages participation in the livestock competitions by giving public recognition, in front of the sale audience each year to Michigan youth for their agricultural studies.

Scholarships and educational awards. The conduct of the Sale-Abration also advances the education of those recipients whose scholarships and educational awards are in part financed by revenue from the "Sale-Abration". Scholarships will be awarded to youth livestock exhibitors, who are planning to attend an institution of higher education or trade school and have competed for at least three years at the Michigan State Fair of the Livestock Expo.
