Part III, The organization's primary purpose is to mobilize resources to support charitable projects for basic education scholarships for poor children and to provide nursing homes and shelters for the elderly, homeless and mentally ill.

The scholarships are provided for poor children of the Instituto Don Bosco in Popayan, Colombia. The Don Bosco Instituto is a non-government organization dedicated to provide basic education to the children of very low income families. This institution functions in accordance to Colombian national educational laws and uses those guidelines to select scholarship recipients. The Instituto's operational budget is very limited even though it receives some help from the government and private donations.

Part 1, Line 10 = Grant money was provided to Vincent Home for the Elderly in the amount of \$1,000 and scholarships were granted to the Don Bosco Instituto and Christ the King School for \$16,200.
