API works nationally with small and large nonprofits. However we focus on smaller and newer community organizations in the Twin Cities.

1. Provide technical assistance to new charitable organizations in the areas of fundraising planning, writing and implementation, primarily through solicitation of grants for education and human service organizations.
2. Provide technical assistance to new charitable organizations in planning the nonprofit organizations development, including board development, organization planning, incorporation and program planning
3. Provide technical assistance to new charitable organizations in the areas of financial planning, including budgeting, income planning and financial controls

Access Philanthropy Charities provides this technical assistance in three ways:

1. One on one consultation with organization board members or managers
2. Written materials, such as grant proposal templates
3. Training sessions for board and staff
