The purpose of "I43, Inc." is encourage, equip and empower the Christians and local churches to fulfill the Great Commission
(from Matthew 28:18-20) of Jesus Christ to the ends of the earth. The name of the organization comes from Isaiah 43:6-7, 21. God is bringing
people from all over the world to this nation, and the churches have the privilege and responsibility to share the love and truth of Jesus Christ
with all of them. To that end "I43 Ministry" promotes prayer meetings, evangelism/training seminars, missionary training workshops,
and outreach events. The organization plans to offer ESL and citizenship classes to immigrants/refugees to help them adjust to life
in America, regardless of their ethnic and religious background.



Isaiah 43:6-7,21 - *"Bring my sons from afar and my daughters from the ends of the earth—everyone who is called by my name, whom I created for my glory, whom I formed and made...the people I formed for myself that they may proclaim my praise."*

The vision for "I43" Ministry* was birthed out of prayer in the spring of 2011 to help churches in the US fulfill the Great Commission (Matthew 28:18-20) by reaching out to the growing number of foreigners who are now their neighbors. Over the last few years, the US has seen increasing number of immigrants, international students, and refugees coming from all over the world: Muslims, Hindus, Buddhists, animists, and atheist Chinese. The mission of I43 Ministry is fourfold. First, we will mobilize, equip and train local churches to effectively share the love and truth of Jesus Christ with the foreigners in their community. Second, we will assist local churches in establishing healthy and effective small groups or house churches for the discipleship of new believers from different cultural backgrounds. Third, we will mobilize and train next generation of missionaries. Fourth, we will provide mentoring and coaching for missionaries who are either on the field or on home assignment.

*I43 Ministry derives its name from Isaiah 43:6-7,21.

5-YEAR TIMELINE:

2011:

- Began praying with friends about I43 Ministry, and the Lord's guidance towards its establishment and mission
- Began meeting with local church pastors/evangelists about ministry to Muslims
- Began teaching Muslim outreach seminars
- Regularly met with Muslim immigrants, students to meet their practical need as well as share with them the message about Jesus Christ
- Attended several conferences on Muslim outreach
- Spoke at missions conferences and churches to raise up missionaries from the next generation
- visited missionaries on the field to encourage them in their ministry

2012:

- Began process of registering "I43" as a 501c3 entity
- continue ministry to Muslim immigrants and refugees in sharing the Christian faith
- continue teaching Muslim outreach seminars, speaking at missions conferences
- provide coaching/mentoring to singles and couples who are preparing to be long term missionaries ("Ready, Set, Go!" seminars)

2013-2014:

- Begin annual fundraising banquet/event for I43 Ministry
- Establish "International Learning Center" where immigrants and international refugees can find practical help for adjustment to life in the US (ESL classes, citizenship classes, computer classes, etc.)
- Expand outreach seminars to include evangelism to Hindus and Buddhists
- Establish "Ministry Training Center" where members from local churches can learn how to evangelize and disciple people from other cultures
- help local churches to start small groups for new believers from cross-cultural

background

- Assist churches and denominations in planning and executing mission conferences that focus on reaching out to the people from other cultures
- Help local churches prepare and implement short term mission trips that include outreach efforts in the immediate locality of the church

2015-2016:

- Establish missionary support program for those who are returning to DC area for furlough or home assignment
