Our services to adults with disabilities include day services, community integration, work/prevocational services, sensory integration, adult respite, and transportation. These programs focus on life skills training, recreation and leisure time activities, social skills, and community access. Included in the curriculum are special interest classes which have included photography, fitness, and scrapbooking. Life skills training include cooking, personal hygiene and appearance, and healthy lifestyles. The recreation, leisure time and social skills component is experience based learning in community settings and includes accessing community recreation and leisure resources, including parks, museums, libraries, theaters for live performances, and participating in multicultural events. The Exceptional Americans, along with the Summer Student Program, provides training through social modeling and experience based learning, decision making skills, self-direction, accessing technology, and interpersonal communication. Our sensory integration component adapts Montessori concepts to teaching adaptive behaviors to persons with sensory input disorders and attention deficit. Outcomes include self-directing to less stimulating environments when the person determines that too much sensory input is triggering a disruptive behavioral reaction. The Caring Connection, our adult respite (Continued on Schedule O, Statement 1)

Community employment training and job placement programs are designed to provide persons with the opportunity and choice to work in the least restrictive, non-segregated environment possible and acquire the necessary job skills for competitive employment. components of the program include a vocational assessment, developing an individualized job plan, job development, training and job coaching, and follow along support when necessary. This program also offers participants an opportunity to create a career path by taking courses at Nicolet College that builds on the necessary employability skills for long term employment. In 2012 the community employment program served 90 individuals. 36 people were referred from the State of Wisconsin Division of Vocational Rehabilitation, three from the Great Lakes Inter Tribal Council, and the remaining referrals came through various agencies. 45 (50%) of the people in jobs earned minimum wage or better

Enterprise activities provided jobs and a paycheck for over 100 individuals last year. Activities include packaging and sewing for one of the largest pet supply companies in the world-Doctors Foster & Smith, and sorting and packaging feathers for Trueflight Manufacturing. We have an industrial sewing contract with the Wisconsin Department of Corrections. We also received three Hall of Fame awards from the State of Wisconsin for our outstanding work performance with Oneida, Vilas, Lincoln, and forest Counties Rest Area Maintenance Program. We also contract with the Wisconsin Department of Natural Resources for grounds maintenance at two public boat landings. We have a spring clean up contract with our local hospital. Our auto reconditioning program and our confidential document shredding program provided consistent work for participants. 41% of our participants increased their wages in 2012. 99.99% of all available time was spent working and production income increased by 18%.
