By providing training, support and a variety of community experiences, the Challenge Center helps adults with developmental disabilities to develop their individual strengths and to become integrated more fully into their community.

Residential services provide a continuum of care options including five community based residential facilities (6-7 bed), 2 adult family homes (4 bed), 3 supervised apartments (6 bed) and an independent living support program. Each resident has their own private room and is provided appropriate care, treatment and training based on their individual needs. The 57 total beds provided 20,271 days of service in 2012. Reflecting the focus on community integration, residents participated in 12,790 community activities last year for an average of 234 activities per resident. The independent living support program serves individuals living in their own homes or preparing to transition into an independent setting. One-to-one services that included support and training components were provided to over 30 adults with disabilities in 2012 with 5,168 hours of service

Adult day and work services provide a variety of programs appropriate to the various functional levels of the population of adults with disabilities served. The sensory stimulation program, serving adults with severe to profound disabilities, provided 17 individuals with 17,947 hours of service. Adult day services include life skills and the seniors programs, providing daily living skills training and activities to adults with severe disabilities, served 36 individuals with 42,314 hours of service. Work services provide assessment, training and employment to adults with moderate to severe disabilities and offered 63,729 hours of service to 62 individuals. Evening/weekend recreation and leisure time activities programs directly integrate consumers into their community, with 15,645 hours of service provided to over 70 participants. 97% of participants achieved at least 2/3 of their personal program goals during 2012. Our community employment program provided job placement services to two individuals and a new assessment service is contracted for youth transitioning from Superior High School in 2013.

Enterprises were created to act as a platform for the work services program and to meet the mission in serving consumers. Marathon Industries and Bay Produce provided the environment for the employment and training of the 62 individuals enrolled in our work services program, resulting in their receiving \$122,165 in wages during 2012. Marathon Industries, begun in 1980, performs light assembly, packaging, labeling, and mailings through subcontracts with area businesses, as well as confidential paper shredding for customers throughout the area. The paper is then baled and recycled. Bay Produce started in 1986 and operates two greenhouses using hydroponic technology to grow beefsteak tomatoes, grape tomatoes, and colorful bell peppers in a sustainable manner. Wholesale distribution totaled 393,228 pounds of produce in throughout the region in 2012. Other enterprises have included space rental, professional training and contracting personal care workers to a home health agency. A total of 36,688 hours of personal care were provided during the year.
