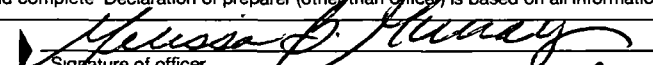

provide funds for programs and projects of The Pewaukee Public Library which are beyond its annual operating budget, and to build
an endowment fund.
