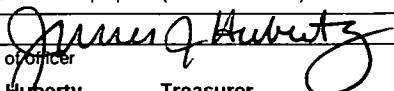

formerly lived in mud houses, so that they can improve their living conditions Houses cost approximately \$1,000 each, each house can
sustain 4-6 extended family members

Item 2: \$22,580 for Micro Loans and related project needs - for small loans to villagers, many of them widowed females, for small
businesses and sustainable start-up businesses The loans enable villagers to purchase livestock and other supplies, and to begin new
businesses, such as a fish sauce processing project. Funds also used by Phan Van Do (honoraum) and project related expenses

Item 3: \$10,000 for Well for Water Project - project involves drilling for water, where the water will be then be pumped to various locations
locally for community use In addition to drilling, funds are used for the pumps, pipes, faucets, and supplies for the basins
