

DURING 2012, GBF PROVIDED BLOOD-RELATED EQUIPMENT TO A NUMBER OF DEVELOPING BLOOD SERVICES THROUGH ITS "EQXCHANGE" PROGRAM. THIS PROGRAM SOURCES SURPLUS-TO-REQUIREMENT EQUIPMENT FROM COLLECTION AGENCIES IN THE US, CANADA AND EUROPE, IDENTIFIES IN-NEED BLOOD SERVICES IN LOW-HDI COUNTRIES AND MANAGES THE LOGISTICS OF RE-HOMING. IN MANY CASES GBF IS ABLE TO SECURE DONATED THIRD-PARTY LOGISTICAL SUPPORT, THEREBY MINIMIZING THE DIRECT EXPENSES INCURRED. THE BENEFIT VALUE IS A SIGNIFICANT MULTIPLE OF THIS LOGISTICS EXPENSE. GBF HAS SINCE WORKED TO DEVELOP AN ONLINE PORTAL TO INCREASE THE VOLUME OF TRANSACTIONS AND CREATE EFFICIENCIES.
