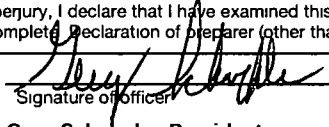

Inter-class competition is held at the end of the season. We also participate in the Holiday Folk Fair in November, as well as Sokol district and national competitions.

Two college scholarships are awarded each year; one to a high school graduate who is a close relative of a member or associate member, and the other to a member or associate member seeking an advanced degree. Both must be of good moral standing, scholastic achiever and have been of service to the organization.

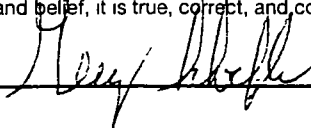
