

Compensation of the Secretary Treasurer is established through the regular union contract, (based on the wage scale of a general foreman) adjusted for 45 hours per week, and approved by the Board, to be reviewed on a yearly basis.

Compensation for Business Representative, is based on the regular union contract, (general foreman rate) adjusted to 45 hours per week, and approved by the Board every two years.

Other Board members, (VP, Recording Secretary, Inside Guard, E Board members and Finance Committee members) are compensated for their attendance at Executive Board meetings, Finance Committee meetings, by-law meetings, or other required meetings where they serve as a delegate to represent the local, at the rate of one hour of general foreman's rate. This remuneration policy is reviewed and approved every two years.

If a Board member serves as a delegate to a convention, in order to represent the local, they are compensated at their normal prevailing wage rate for each working day they are required to be on convention duties. Their attendance at such conventions is voted on by the membership. Compensation for all other employees is established at the regular union contract rates, and approved by the Board every two years.
