Prevention and Education Public education and the implementation of prevention-based programming are very important elements to the overall mission of the Rape and Abuse Crisis Center Trainings and presentations are available to places of employment or community groups on issues of healthy relationships, domestic violence, sexual assault, sexual harassment, child abuse, or other issues of violence In the area of prevention-based education, numerous presentations and programs are presented to local schools regularly Programming includes red flag green flag people personal safety curriculum, the "I Wish the Hitting Would Stop" domestic violence prevention program, and for older students, programming related to healthy relationships and dating violence is available In 2012, The Rape and Abuse Crisis Center provided 856 presentations reaching 15,872 individuals 602 presentations reached 13,641 elementary, middle, high school and college students, 141 presentations reached 1,753 community members, and 26 presentations were provided to 464 professionals (law enforcement, nurses, social workers, etc) Engaging the community in working to prevent domestic and sexual violence is an important part of the Center's work In 2012, RACC facilitated a committee of 50 community leaders to plan and execute a community summit to prevent sexual and domestic violence It's Everyone's Business Summit to Prevent Domestic and Sexual Violence held on September 18, 2012 brought together 175 local and state leaders from government, industry, academia, media, philanthropy, faith and non-profit issue experts to identify and discuss effective prevention practices and strategies in our community Sexual Assault Services The Rape and Abuse Crisis Center (RACC) provides crisis intervention, advocacy and counseling to victims of sexual assault and child sexual abuse Crisis intervention includes staff and volunteers responding to the immediate needs of victims In 2012, RACC served 1,040 victims of sexual assault, 336 of those victims were children RACC is a member of the community sexual assault response team (SART) Advocacy services may include assistance to victims during hospital exams, law enforcement investigations, and with obtaining orders for protection Ongoing counseling services are provided to primary and secondary victims Advocates provided service to victims of sexual assault at Emergency Centers on 86 occasions in 2012 Domestic Violence Services The Rape and Abuse Crisis Center provides crisis intervention, advocacy and counseling to victims of domestic violence In 2012, RACC provided services to 1,717 victims of domestic violence including 123 children Crisis intervention includes staff and volunteers responding to the immediate needs of victims following an incident of violence Advocacy services may include assistance to victims during hospital exams, law enforcement investigations, and with obtaining Orders for Protection In 2012, RACC assisted 144 victims in obtaining emergency Orders for Protection Counseling services are provided to primary and secondary victims following the initial crisis RACC also works with local law enforcement officials to reach out to victims identified in domestic violence incident reports, in 2012, staff reviewed 1,363 reports and made contact with 1,011 victims Victims were provided with information on the criminal justice system, their rights and services available to them RACC provides emergency financial assistance to victims who need help with food, rent, utilities, transportation, medication, and other necessities Advocates responded to victims of domestic violence in Emergency Centers on 27 occasions in 2012
