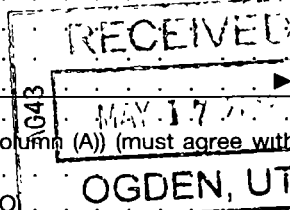

LINE 28: The ALTERNATIVES TO VIOLENCE PROJECT serves inmate of Minnesota corrections facilities, residents of county jails, as well as members of the general public, by teaching non-violent conflict resolution and compassionate communication. In 2012, 25 volunteers facilitated 35 workshops at 6 prisons, and 5 community workshops engaging 641 prison and 57 community participants.

LINE 29: PEACE EDUCATION & ADVOCACY educated community members and public officials on the transforming power and practice of non-violence and on vital national and international issues concerning peace & justice. In 2012 we focused on conflicts involving Iran, Syria, Palestine/Israel and US foreign policy (Patriot Act, ending the war in Afghanistan). We hosted a MN ASAP speaker event which 40 people attended. To support the MN ASAP resolution, 6 people were present at Minneapolis and St. Paul City Council meetings. About 25 participants in the Minnesota Peace Project communicated with the 10 members of Minnesota's US Congressional delegation. 48 people attended one of 2 sessions held to train volunteers working to defeat the proposed Minnesota constitutional amendment banning same-sex marriage. The Syrian Support Network, by email, promoted awareness of the Syrian non-violent movements to about 2100 people. The Book Club (9 participants) met once per month to discuss books concerned with the practice of non-violence, country histories, political perspectives and the social development of today's US and world environment. Four newsletters were published and distributed to 400 people;
