Part XII 2C: Oversight of the books for the center have remained the same for many years. The bookkeeper of the center is a volunteer and on the board of director serving in the capacity of treasurer. Since he is a volunteer, he does the financial work off the campus of the center in his own personal office. The centers office manager pays all the bills and makes all deposits. At the end of the month a spreadsheet is forwarded to the treasurer and the transactions are entered into the books for the center. Payroll is paid on a semi-monthly basis and again, the hours are forwarded to the treasurer and payroll is calculated and paid and sent out to the employee home addresses by mail. The treasurer is in charge of the payroll withholding for both the federal and state and pays the blances as required by law. The board of directors meet on the odd months of the year and at our meetings we go over the financials in very much detail. With this process, there are three different people working with the finances and the board of directors feel that the accountability is very high and that the books and records are accurate.
