In addition, Shalom honored 1,240 free merchandise vouchers (valued at up to \$10 each) issued by these organizations. Through information collected by the organizations assisting others, over 16,000 individuals and 6,400 families were assisted in 2012.

The largest distributions from Shalom go to the local food shelves who distribute food to those in need.
