<b>28</b> Freedom Place provided transitional housing to 36 individuals in 2012, including 8 women and 28 men. The average stay was five months. We evicted 10 clients for violating the sober lease. Twelve moved on to permanent housing and fourteen clients remained in the program entering 2013. We provided job training and part-time employment to 14 clients and paid out a payroll of \$45,209.75. The jobs included housing rehab and fundraising. We also ran weekly support groups and gave residents the opportunity to volunteer and grow healthy fruit and vegetables in our organic garden project we run every summer. In 2012, we did major remodeling work in two of our homes. At 404 Charles, we gutted the interior walls on the first floor and re-dry-walled the whole floor. Also we built a dormer on the roof to provide more headroom on the second floor stairwell. We completely remodeled the kitchen with new cabinets, flooring and plumbing. We hired an electrician to rewire much of the home. Finally, we dry-walled two ceilings and built a back porch and deck at 653 Dale.
