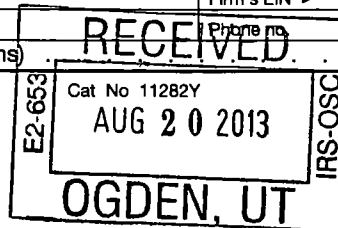

RAAN's partner clinics and infectious disease Specialists provided primary medical care to 248 PLWHA, who made 758 visits

RAAN staff and partner agencies conducted 488 free rapid HIV tests. Each participant received prevention counseling

RAAN Medical Case Managers served 255 clients through 9372 visits or contacts

RAAN helped 95 clients access medical services and adhere to treatment regimens by paying for doctor visits and Rx medications

More than 50 PLWHA attended at least one meeting of RAAN's support groups

RAAN provided medical transportation to 186 clients

Through outreach and educational events, RAAN provided HIV/AIDS education and prevention materials to over 24,000 persons
