THE AMERICORPS FIELD PROGRAM ENGAGES YOUNG ADULTS, AGES 18 TO 25, IN NATURAL RESOURCE AND EMERGENCY RESPONSE WORK THROUGHOUT MINNESOTA AND IOWA. IN 2012, 165 PARTICIPANTS SERVED 7 TO 11 MONTH TERMS RESTORING HABITAT AND 43 PARTICIPANTS SERVED 3 MONTH SUMMER TERMS IMPROVING TRAILS IN MINNESOTA NATIONAL FORESTS. IN TOTAL, AMERICORPS MEMBERS DEDICATED 302,412 HOURS OF SERVICE AND REMOVED INVASIVE SPECIES FROM 19,425 ACRES, PLANTED 114,838 NATIVE TREES AND SHRUBS, CONDUCTED PRESCRIBED BURNS ON 32,355 ACRES OF PRAIRIE, AND COMPLETED 775 MILES OF TRAIL WORK. AMERICORPS MEMBERS RECEIVE A MONTHLY STIPEND, HEALTH INSURANCE, AND AN EDUCATION AWARD FOR COLLEGE EXPENSES. BESIDE CAREER AND WORK-SKILLS TRAINING, CORPS MEMBERS RECEIVE PROFESSIONAL CERTIFICATIONS IN WILDFIRE SUPPRESSION, DEFENSIVE DRIVING, CHAIN-SAW SAFETY AND FIRST AID.

YOUTH OUTDOORS IS A SERVICE-LEARNING PROGRAM FOR SAINT PAUL AND MINNEAPOLIS YOUTH, AGES 15 TO 18 FROM LOW-INCOME HOUSEHOLDS. IN 2012 DURING EACH 12-WEEK SEMESTER, 36 YOUTH AND 12 CREW LEADERS WORKED IN SIX CREWS AFTER SCHOOL AND SATURDAYS. YOUTH ALSO PARTICIPATED IN A FOUR-WEEK SUMMER SESSION. THEY COMPLETED NEIGHBORHOOD REVITALIZATION AND ENVIRONMENTAL PROJECTS WHILE EARNING A STIPEND. IN TOTAL, 87 YOUTH AND 13 AMERICORPS MEMBERS COMPLETED 30,652 HOURS OF SERVICE-LEARNING THAT INCLUDED MANAGING AND REMOVING EXOTIC PLANT SPECIES AND VEGETATION ON 1,988 ACRES OF LAND, PLANTING OVER 24,285 TREES AND SHRUBS, REMOVING OVER 2,100 POUNDS OF DEBRIS, AND ENGAGING IN 4,484 HOURS OF ENVIRONMENTAL EDUCATION.

THE RESIDENTIAL SUMMER YOUTH CORPS ENGAGES DIVERSE YOUTH, AGES 15 TO 18, IN ENVIRONMENTAL-RESTORATION PROJECTS DURING TWO SUMMER SESSIONS, EACH FOUR WEEKS LONG. IN 2012, 130 YOUTH PARTICIPANTS, 24 AMERICORPS MEMBERS, AND 6 PART-TIME STAFF COMPLETED 37,664 HOURS OF ENVIRONMENTAL SERVICE-LEARNING PROJECTS. HALF OF THE 130 YOUTH WERE FROM THE TWIN CITIES AREA AND HALF WERE FROM GREATER MINNESOTA. IN ADDITION TO NATURAL-RESOURCE WORK EXPERIENCE, THEY LEARN SKILLS SUCH AS CIVIC LEADERSHIP AND RESUME WRITING. THIS PAST YEAR, YOUTH CREWS BUILT AND MAINTAINED 112 MILES OF TRAIL, MANAGED EXOTIC SPECIES ON 592 ACRES, REHABBED 332 CAMPSITES, AND ENGAGED IN 2,510 HOURS OF ENVIRONMENTAL EDUCATION. PARTICIPANTS RECEIVE A LIVING STIPEND AS WELL AS ROOM AND BOARD. YOUTH BEGIN AT A BASE CAMP, THEN "SPIKE CAMP" THROUGHOUT THE REGION AS THEY WORK. AMERICORPS MEMBERS RECEIVE A MONTHLY STIPEND, HEALTH INSURANCE, AND AN EDUCATION AWARD FOR COLLEGE EXPENSES.

IN 2012, 8 PARTICIPANTS SERVED 11 MONTH TERMS ON SPECIAL PROJECTS WITH THE MINNESOTA AND IOWA DNR, 22 PARTICIPANTS SERVED TERMS IMPROVING ENERGY EFFICIENCY IN HOUSES, 41 PARTICIPANTS SERVED SUMMER TERMS COMPLETING CONSERVATION PROJECTS.
