


Civil rights, democratic development, emergency aid, and advocacy programs - Los Olivos CIS promotes grassroots organizing in various communities. Twenty-four community organizations currently make up the "Community Network for Cooperation and Solidarity." Los Olivos CIS plays a role in the campaign for water rights and the Roundtable against Metallic Mining. The CIS also supports educational campaigns of SIGESAL, the public hospital workers association for medical reform and workers rights, and legalization of land titles. CLEAN WATER is currently a major focus of CIS community assistance efforts. 260 Sawyer water filters were distributed to 12 communities in 2012 and a total of 479 filters to 16 communities since we began the program in 2011. The CIS clean water campaign not only distributes filters and teaches families how to use and maintain them; we also do a two-day training on the environment, health, and water prior to the distribution. Through an agreement with Clean Water for the World (CW4W), we also installed eight industrial filters, primarily in educational centers. ELECTION OBSERVATION: The CIS organized its 9th International Election Observer Mission thanks to 11 volunteers and 88 additional international observers. CIS Mission was met with government officials, political parties, candidates political analysts, non-governmental organizations, and visit

Youth formation and Scholarship Programs - provides education to potential community leaders who would not be able to study without help and at the same time build their awareness of their role as agents for making changes for social justice. In 2012, this program was organized in 11 communities, providing 194 high school and 94 university scholarships. Los Olivos CIS coordinated with 12 churches, foundations, solidarity groups, and schools in the U.S. to fund these scholarships. Monthly leadership, formation and analysis sessions were organized for students and their parents by CIS community organizers. Scholarship recipients also carried out volunteer programs including community clean-ups, clean water campaign follow-up, tutoring grade school students in reading and writing, coordinating a health campaign with a clinic, and much more.

International cultural exchange and education: educational delegations and language and cultural exchange. 28 international volunteers plus students majoring in English at the University of El Salvador taught English classes to local community members. The volunteers also receive orientation to El Salvador and the empowerment work of Los Olivos CIS. 130 international participants received Spanish instruction and cultural orientation from local native speakers. 152 participants in 15 international delegations/work brigades from universities, parishes, sistering relations, solidarity groups and others visited El Salvador to gain an in-depth understanding of the social and economic reality of El Salvador as well as to promote solidarity with communities and grassroots organizations working for social and economic justice.
