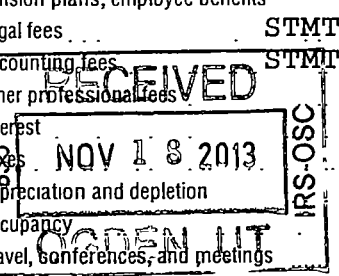

ARTICLES OF INCORPORATION
OF
CHRISTOPHER INN INC.

ARTICLE I

The name of this corporation shall be Christopher Inn Inc.

ARTICLE II

~~The registered office of this corporation is located at 7760 France Avenue, Suite~~
1100, Minneapolis, Minnesota 55435.

ARTICLE III

This corporation is organized exclusively for charitable, religious, and educational purposes, within the meaning of Sections 170(c), 501(c)(3), 2055(a) and 2522(a) of the Internal Revenue Code of 1986, or such other provisions of Minnesota or Federal law as may from time to time be applicable. The specific purpose of this corporation is to support the life and ministry of Roman Catholic bishops and priests worldwide. This corporation shall have all the powers now or hereafter conferred upon it by the statutes of the State of Minnesota, including but not limited to, the power to acquire, hold, lease, encumber, convey or otherwise dispose of real or personal property within or without the State, and to take real or personal property by will or gift.

ARTICLE IV

At all times the following shall operate as conditions restricting the operations and activities of this corporation:

- 4.1 No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its directors, officers, or other private persons, except that organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof.
- 4.2 No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, except to the extent, if any, permitted by the Internal Revenue Code of 1986, as amended, and regulations thereunder. Nor shall this corporation participate in, or intervene in (including the publication or distribution of statements), any political campaign on behalf of, or in the opposition to, any candidate for public office.

- 4.3 This corporation shall not carry on any activities not permitted to be carried on by an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future tax code, or by an organization, contributions to which are deductible under Section 170(c) of the Internal Revenue Code of 1986, or corresponding section of any future tax code.

ARTICLE V

This corporation shall have no members.

ARTICLE VI

- 6.1 The management of this corporation shall be vested in a Board of Directors.
- 6.2 The number, qualifications, and terms of office of the directors shall be fixed by the Bylaws of this corporation.
- 6.3 Any action required or permitted to be taken at a meeting of the Board of Directors may be taken by written action signed by the number of directors that would be required to take the same action at a meeting of the Board of Directors at which all directors were present.

ARTICLE VII

No officer or director of this corporation shall be personally liable for the debts or obligations of this corporation, nor shall any of the property of the officers or directors be subject to the payment of the debts or obligations of this corporation.

ARTICLE VIII

No director or officer of this corporation, nor any private individual, shall be entitled to share in the distribution of any of this corporation's assets on its dissolution. In the event of dissolution, all property and assets remaining (after payment of costs and expenses incident to the dissolution proceedings and after payment, satisfaction, discharge or provision for liabilities and obligations of this corporation) shall be distributed to organizations that are faithful to the Magisterium and teachings of the Roman Catholic Church, to be used exclusively to provide services to Catholic clergy, as the Board of Directors may determine; provided that at the time of distribution a recipient organization is organized and operated exclusively for religious, charitable or educational purpose within the meaning of Section 170(c), 501(c)(3), 2055(a) and 2522(a) of the Internal Revenue Code of 1986, as amended.



ARTICLE VI

INDEMNIFICATION

To the full extent permitted by the Minnesota Nonprofit Corporation Act, as amended from time to time, or by other applicable provisions of law, each person who was or is a party or is threatened to be made a party to any threatened, pending or completed action, suit or proceeding, wherever and by whomsoever brought (including any such proceeding, by or in the right of the corporation), whether civil, criminal, administrative or investigative, by reason of the fact that he or she is or was a director or officer of the corporation, or he or she is or was serving at the specific request of the Board of Directors of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise, shall be indemnified by the corporation by the affirmative vote of a majority of the directors present at a duly held meeting of the Board of Directors for which notice stating such purpose has been given against expenses, including attorneys' fees, judgments, fines and amounts paid in settlement actually and reasonably incurred by such person in connection with such action, suit or proceedings provided, however, that the indemnification with respect to a person who is or was serving as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise shall apply only to the extent such person is not indemnified by such other corporation, partnership, joint venture, trust or other enterprise. The indemnification provided by this Article shall inure to the benefit of the heirs, executors and administrators of such person and shall apply whether or not the claim against such person arises out of matters occurring before the adoption of this provision of the Bylaws.

ARTICLE VII

AMENDMENT OF BYLAWS

The Board of Directors may from time to time by the affirmative vote of two-thirds (2/3) of the directors present at a duly held meeting, adopt, amend or repeal any of the Bylaws of this corporation. Written notice of the meeting and of the proposed amendment shall be given to each director not less than five (5) nor more than thirty (30) days before any meeting of the Board of Directors at which an amendment of the Bylaws is to be adopted.
