| Exhibitions. Midway produced five monographic exhibitions in 2012, including US solo debuts of German photographer Jochen Lempert, Scottish artist Sue Tompkins, and the Brussels-based artist David Catherall. In addition, we presented the work of New York-based Jordan Wolfson and the Minneapolis-based Katelyn Farstad. Over 5,000 individuals attended the exhibitions. Library. Midway's library collection grew to 4,000 volumes in 2012. With the collection having expanded since its inception in 2007, we conducted a \$50,000 capital campaign to expand the library facility. At the close of 2012, we began construction and completed this expansion in February 2013. The library is now 1,250 square feet, with additional shelves for future growth. The library will now be able to accommodate the additional attendees at Midway artist and curatorial talks and film screenings. Education. In 2012, Midway hosted 50 student and group tours that provided 750 students with 550 hours of personalized tours of exhibitions and library research time. In addition, we worked with 150 volunteers and interns from local area graduate and undergraduate schools and universities.
