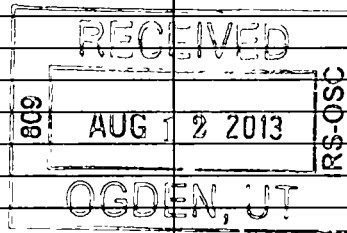

- Scholarships will be awarded based on a review of all applications postmarked by April 30th
- Reviews will be conducted by the Foundation Board of Directors, whose decision will be final
- Scholarship recipients will be asked to provide a letter of acceptance and a remittance address for the educational institution of their choice
- Scholarship funds WILL NOT be paid directly to individuals
