Community members can participate in our 5K Run/Walk and then celebrate with family and friends. We tailor the day towards families, as we know the importance of building family relationships. Prizes are given away, a free picnic lunch is provided, and fun is had by all.

Day of Caring: Each year, United Way of Mahaska County empowers volunteers in our community to come together to assist in completing projects for those in our community that might otherwise not be completed. In 2012, we completed 19 projects with approximately 150 volunteers.

non-profits. These seminars were geared toward offering information to improve effectiveness in management of a small non-profit and

provided an opportunity for local agencies to share ideas.

Operation Backpack: Expenses - \$1,808 - Each fall, United Way of Mahaska County helps children of low income families by providing the

necessary supplies for the upcoming school year. Any child, preschool through 12th grade, is eligible for assistance in this program.

In 2012, we supplied over 300 backpacks to children in Mahaska County. Leftover supplies were given to local schools to stock

school supply closets to be utilized by teachers throughout the school year. We partnered with SIEDA, Love In the Name of Christ,

Salvation Army, and the school districts in Mahaska County.

VITA Tax Site: Expenses - \$321 - United Way of Mahaska County recruits volunteers, coordinates and hosts a VITA Tax Preparatio

Assistance Site. IRS Certified VITA Tax Preparers provide free tax preparation for low income families and individuals.

Volunteer Appreciation Open House: Expenses - \$144 - Once a year, we take the opportunity to give something back to all of the

volunteers that give of their time each year to our United Way and to our funded agencies. We highlight a Volunteer of the Year and

give away great gifts to our volunteers.

Literacy Program: Expenses - \$0 - United Way of Mahaska County has a unique program for the members of our community. In our

United Way building, we house numerous used books, CD's and magazines that are free to the public. We have a variety of options

to choose from for all ages. All books are donated by local residents and United Way incurs no cost in providing this resource to the

community. We are working on new ways to share literature with more community members each year.
