The president gives a formal report at the December meeting. Following the report, the board discusses and approves salary for the following year (executive director is absent for this discussion). The approved salary is effective beginning January 1st. Regarding the use of comparability data, every three years, the board reviews the Human Capital Study conducted by United Way Worldwide as well as surveyed responses from similarly sized United Ways in the Midwest.
