Shelter House provides shelter to men, women and children, including overnight housing, breakfast and an evening meal, bathing and laundry facilities, a mailing address and a place to receive phone calls and messages In the most recent fiscal year, Shelter House served 612 different individuals (99 of whom were children) by providing 25,365 nights of shelter The drop-in center provided a range of services to over 460 individuals that did not stay overnight These services include showers, laundry, phone calls, and access to donations, bus tickets, and outreach

The Supported Training and Access to Resources (STAR) Grant provides vocational training with comprehensive case management services including life-skills training, educational assistance, child care services, transportation, and housing and employment placements Through the STAR Grant, clients develop their own personal resources and skills and work toward increased economic independence Many clients are able to find and maintain employment and stable, affordable housing, while actively participating in the life of our community 384 adults participated in STAR of whom 76% moved to more permanent housing 89% exited with at least one source of income 57% exited with employment income 272 adults participated in skills workshops, increasing both skills and knowledge The Homeless Veterans Reintegration Program had 54 participants, and half were placed in competitive employment Upon completion of the Culinary Training Program, trainees are more competitively positioned for employment in local restaurants and commercial/industrial kitchens Of the seven Culinary Starts graduates, five are employed in the food production industry and living independently 21,365 nutritious meals were served at Shelter House using trainees
